## Decisions Received on Two Lawsuits Against the Town

On July 12, 2012, a lawsuit was filed by Old School Cape Charles, LLC and Wayne Preston Creed. On September 20, 2012, a second suit was filed by Old School Cape Charles, LLC, Wayne Preston Creed, Laura Hickman McSpedden and John L. Hickman. These lawsuits were regarding the sale of the former school building and subsequent zoning amendment which were approved by the Town Council in June 2012. A hearing was held on January 25, 2013 for both lawsuits at the Northampton County Circuit Court. On February 28, 2013, Town Manager Heather Arcos received notification from the Town's attorneys regarding Judge W. Revell Lewis, III's decision on the two lawsuits filed against the Town. Both lawsuits have been dismissed with prejudice.

On February 1, 2013, another lawsuit was filed by Donald Riley regarding the planned bathroom facility at Central Park. The hearing has been scheduled for April 15, 2013 at the Northampton County Circuit Court.
