



# Eastern Shore Route 13 Safety Study



VDOT has a safety study underway evaluating the section of U.S. Route 13 from the Chesapeake Bay Bridge-Tunnel to the Maryland State Line, and Route 175 from U.S. Route 13 to the Town of Chincoteague. The study includes two parts: 1) providing an evaluation of the effectiveness of the safety treatments installed as a result of the 2002 Route 13 / Wallops Island Access Management Study; and 2) a two-phase safety assessment with evaluation of focus locations and a systemic corridor review.
