



The Cape Charles Town Council supports the Virginia Main Street initiative and the town joining the program initially as a Community Affiliate member and working toward full designation as a Main Street Community. The goal of a Community Affiliate is to employ the Main Street Approach in the development of the organizational stability and public-private partnerships necessary for successful administration of a downtown revitalization program. The Community Affiliate core services include: access to training by state and national downtown development experts; organizational structure development assistance; and eligibility for grants through the Department of Housing and Community Development (DHCD) as available. Communities must be an affiliate member of the National Main Street Center to demonstrate its commitment to the Main Street Approach methodology prior to application for full Main Street designation.

Tourism Zone Ordinance Gazette Article

The Town Council adopted the Tourism Zone Ordinance at its regular monthly meeting on November 17, 2016. **The effective date of the ordinance is retroactive to January 1, 2016.** The purpose of this Ordinance is to provide certain tax and fee credit incentives to qualified tourism businesses that develop, maintain, and expand operations and create full and part time jobs. Localities can create Tourism Zones according to requirements found in the Code of Virginia. Please notice that in several sections the Tourism Zone Ordinance text mirror language found in the Town's Technology Zone Ordinance. The Technology Zone Ordinance is Chapter 23 of the Town Code, while the Tourism Zone Ordinance is Chapter 24. Both Ordinances work to encourage private sector investment and economic development in Cape Charles.

As a brief overview, the Tourism Zone Ordinance does the following: 1) establishes a Tourism Zone footprint as the entire Town of Cape Charles; 2) creates an administrative process to implement the Ordinance; 3) defines qualified tourism businesses and establishes eligibility criteria for participation; 4) makes no distinction between seasonal and all-year business operations; 5) defines economic stimulus credits available to qualified tourism businesses; and 6) establishes the award process as a staff recommendation followed by Town Council approval.

Please note the economic stimulus credits provided for in the Tourism Zone Ordinance involve reimbursements to the qualified tourism business for taxes and fees already paid to the Town. No public funds reimbursement will be awarded unless a qualified tourism business has completed the review process and incentive credits have been approved by Town Council at a regular meeting.

Applications are available in the Planning Department office in Town Hall, located at 2 Plum Street.

A REMINDER FROM THE HISTORIC DISTRICT REVIEW BOARD

The Historic District Review Board reminds owners of properties listed on the National Register of Historic Places to consider putting a historic property plaque on their home or business. The plaques help visitors know they are in the Town's historic district, and provides a greater appreciation of the historic district's various architectural styles. Although not required by any state or federal agency, the voluntary placing of a plaque provides information about the date of the building construction and serves to delineate the historic district boundaries.

A NOTE FROM THE PLANNER REGARDING PARKING OPTIONS

The summer season is almost here, and that means many more of the downtown businesses will be opening, more people visiting Cape Charles, and more events happening around town. With this increased seasonal activity comes a higher demand on the available on-street parking along Mason Avenue and the commercial side streets. While this demand is not constant throughout the day or week, certain times and days can produce more vehicle congestion than others. Additional parking spaces were added to the central business district by the installation of the back-in angle parking stalls on Mason Avenue. Parallel parking remains available on the south side of Mason Avenue and on all side streets.

A convenient off-street parking alternative exists at the Town-leased gravel parking lot downtown. The lot is located on the south side of Mason Avenue behind the 300 Mason Avenue construction site and Riverside Cape Charles Medical Center. Parking at that lot is front pull-in, and free of charge. Parking here is useful for those who will be spending a prolonged period of time in town, people uncomfortable with the back-in angle parking, larger vehicles that may extend beyond the parking stall lines, and especially people wanting to park and enjoy a walk around the downtown, harbor, the Shanty, or beach areas. Currently there is no local overhead lighting for this lot, however improvements are scheduled for upcoming years.

2017 TAX FORMS NOW AVAILABLE

The 2017 tax forms are now available online at www.capecharles.org and can be found under Treasurer in Forms & Publications. Hard copies are also available at the Town Office. Business, Professional and Occupational License Tax forms are due by April 15, 2017.

- 2017 Business, Professional and Occupational License Tax for Vacation Rental Owner & Rental Management Business

- 2017 Short Term Rental Tax Form

The 2017 Real Estate Tax Relief for Elderly & Handicapped Persons form is also available. All applications need to be completed and submitted to the Treasurer's Office by April 2, 2017. Copies of the following supporting documentation must also be submitted along with the application: Social Security Statements, Bank statements for October, November and December 2016, Pension Statement, Life Insurance Policies, and Driver's License/Photo ID.

Northampton County also offers this program and the <u>Northampton County Affidavit and Application for Real Estate Tax Relief for Certain Elderly and Handicapped Persons</u> must be submitted to the Northampton County Commissioner of Revenue by February 28, 2017.

A REMINDER FROM THE PUBLIC WORKS DEPARTMENT

Section 58-32 of the Cape Charles Town Code requires:

- (a) All yard waste to be collected by the town shall be placed in yard waste receptacles.
- (b) All vegetative waste to be collected by the town shall be cut into lengths not to exceed 4 feet and shall be stacked neatly by the customary point of pick-up of the public right-of-way for collection. Stacks should not exceed 4' x 4' x 4'. If such material is not prepared for collection as herein required, its disposal shall be the responsibility of the owner or occupant of the premises.

The Public Works Department has been picking up all vegetative waste, even waste which was not stacked in compliance with the Town Code, but will begin strictly enforcing the requirements of the Code effective March 1, 2017.
