IMMEDIATE RELEASE FROM CAPE CHARLES POLICE DEPARTMENT

Bay Coast Rail Road has closed the crossing at the hump to all traffic, golf carts, vehicles, pedestrians, etc. Violators will be prosecuted for trespassing. This closing is a result of a near accident involving their locomotive and a golf cart occupied by adults and 2 children which became stuck on the tracks at night.

The crossing at the Shanty will remain open for pedestrian and golf cart traffic.

NEW TRAFFIC LAWS IN VIRGINIA

There are 2 new traffic laws in the State of Virginia that became effective July 1, 2013:

Code of Virginia § 46.2-1078.1 makes it unlawful to operate a **moving** motor vehicle while using any handheld device to send or read text or email messages. Texting or emailing while driving is a primary offense and is punishable with a fine of \$125 for a first offense and \$250 for any subsequent offenses. The officers have the option to charge the individual with reckless driving, § 46.2-868, where the mandatory minimum fine is \$250.





Operating a Moped: Individuals must be at least 16 years of age to drive a moped. It is illegal to drive a moped if your license is suspended or revoked for DUI/drugs or if you are a habitual offender. Every driver and passenger must wear a helmet while driving/riding a moped. Drivers must also wear a face shield, safety glasses or goggles unless the moped has a windshield.


REMINDER RE: ZONING CLEARANCES

As temperatures rise, there is always an increase in activity regarding projects around the house, whether it is putting up a fence, installing a swimming pool, building a new shed or a new addition to the house. Although some of these projects do not require a building permit, they do require a zoning clearance. Before beginning any projects of this nature, please visit the Town office and obtain a zoning clearance from Town Planner Rob Testerman. It is important to see Rob before beginning these projects so that you can be sure that your proposal is consistent with the Town Zoning Ordinance. PLANNING A PROJECT? HIRING A CONTRACTOR?

Once you decide to have some work done on your property and are ready to select a contractor, here are some things to consider prior to hiring a contractor. By hiring a licensed contractor, you will have peace of mind in knowing that the project will be completed by an individual who has taken the time to acquire the appropriate education and who possesses the necessary experience to properly perform the work. A few other items of note:

- Before you hire a contractor, ask to see a state-issued license and, if required, tradesman card.
- Ask for references. A legitimate contractor will be happy to provide you with the names and contact information of recent customers.
- Get a written estimate from several licensed contractors. Make sure the estimate includes the work
 the contractors will do, the materials involved, the completion date and the total cost.
- Beware of contractors who claim to be the fastest or cheapest. Hiring them could result in poor workmanship, inferior materials or unfinished jobs.
- Be wary of a contractor who asks you to obtain the permit. If the contractor is properly licensed in the State, they should have nothing to hide from.



Often homeowners may feel like performing the work themselves, however, before you make that decision, you should know that obtaining a permit as the homeowner to do work means that you are accepting the responsibility for the work performed and any deficiencies discovered during inspections would be your responsibility. Per Virginia Code Section 54.1-1101 - Exemptions from Licensure, you, as the homeowner, are only permitted to obtain permits on your home only if one of the following applies:

- The work consists of the repair and/or improvement to an existing dwelling which is your PRIMARY residence.
- You are the owner of the property and the structure will be used as your PRIMARY residence when completed.
- You are the owner of the property and the structure will be a gift to a member of your immediate family who will live in it upon completion.

CAPE CHARLES COMPUTER LAB UPDATE

As most of you are aware, the Town received approximately \$18K under the Broadband Grant through the Virginia Department of Housing and Community Development (DHCD) for the purchase of 20 computers and stations for the Cape Charles Computer Lab which was temporarily housed in the Cape Charles Christian School until a new location could be secured to the new library facility. In the fall of 2012, a citizen complaint was made to the Department of Housing and Urban Development (HUD) stating that the Town's computer lab was not available to the public. The complaint was referred to the DHCD which opened an investigation regarding the complaint. In October 2012, the Town purchased the former Bank of America building with the intent to expand the current library which could house the Computer Lab. The DHCD required the computers to be relocated to the new Library facility by 12/19/12 and made available to the public on a "reasonable, limited schedule." A site visit was made by DHCD representatives who found the 201 Mason Avenue building locked and the Town was notified to repay the \$18K granted for the purchase of the computers. The Town had been communicating with representatives from the DHCD in an effort to resolve this matter and in May 2013 submitted an appeal to HUD on the basis that the computers had been relocated and were available to the public on a "reasonable, limited schedule" as required until the relocation of the Cape Charles Memorial Library. The Library reopened in its new location on 5/8 and the computers are available for public use during the library's regular hours of operation.

On 8/6, the Town received notification from Mr. Ronnie Legette, Director of HUD's Richmond Field Office, informing us that the matter was officially closed and the Town did not have to repay any of the grant funding. Notification from US Dept. of Housing & Urban Development



STEP INTO OUR VAULT!

THE LOCAL HISTORY ROOM AT THE CAPE CHARLES MEMORIAL LIBRARY



Are you interested in researching your family's history? Did you or a family member go to Cape Charles High School? Are you interested in the history of the Eastern Shore or Cape Charles in particular? Then you need to check out our Local History Room, located in the larger of our two vaults. This vault contains two areas: one behind bars where we are keeping delicate and very old items that you will need to ask to see, and the front area where reference books on the Eastern Shore and Virginia are kept. These books do not check out but the vault contains a table and chairs where you can get comfortable and do your research (unless you are claustrophobic!).

We are very excited to have an area that we can devote to local history and we want to continue to improve and expand on this collection. Many of the books that are now in the vault were housed in the antique oak bookcase at the former library and were not easily accessible. Now you can look at these old books and marvel at the ornate binding, yellowed pages, and small print.

Since moving into our new building we have been able to accept several donations such as 5 scrapbooks donated by the Cape Charles Historical Society that were put together by Jim Lewis while he was doing research for his book *Cape Charles: A Railroad Town*. Two other donations from the Cape Charles Historical Society include a canceled check from the *Farmers and Merchants Trust Bank* from W.F. Wilkins, Grower and Shipper of Farm Produce dated July 23, 1927 and a bronze plaque with the profile of Guy Lawrence Webster, a leading organizer and Founder of Northampton County Trust Bank in 1933.

One of our most popular collections are the yearbooks from Cape Charles High School. Children love to come in and look up their parents and grandparents pictures and laugh at the old hair styles. Some of the other titles you will find in the vault are: **Northampton County**, **Virginia Marriage Reference and Family Relationships 1634-1800** by F. Edward Wright, **Virginia's Eastern Shore** by Ralph T. Whitelaw, and **Eastern Shore Indians of Virginia and Maryland** by Helen C. Roundtree and Thomas E. Davidson.

The history of the Cape Charles Memorial Library is long and colorful, with its many moves and has been written about numerous times. In the beginning the Library was filled with antique furniture gathered from local homes and today some of those same pieces sit in the current library. The history of the first Presbyterian Church is a part of our library history and we are now incorporating the history of the bank building where we are now located. We would like to preserve all of this history and continue to add to it, learning more about our current home, the Bank of America building. If you have stories or photos you would like to share we would like to add these to our collection. The stories of these buildings are fascinating and make up the history of our community.

As many of you know the Eastern Shore Public Library has an Eastern Shore Room which contains maps, manuscripts, books, fiche and film, and photocopies. This is a good place to do further research. The Eastern Shore Public Library also has digital images of some of the historical Cape Charles documents. Online genealogy resources can be found on the Eastern Shore Public Library web site (www.espl.org).

Clam Slam 2013 was an absolute hit! There were about 2,500 Cape Charles residents and visitors at the Cape Charles Harbor on Saturday, 8/3, and Sunday, 8/4. The Clam Slam's opening ceremony, featuring entertainment by the Shriners in the parade, was the perfect way to awaken the Town to the weekend's festivities.

Clam Slam's energy could be felt radiating throughout the whole town, especially during the Boat Docking Contest on Sunday afternoon where screaming fans watched watermen battle for the Harbor's record docking time. The *Fabricator*, who set the record originally in 2011 in the Singles competition at 36.0 seconds and Teams competition in 2012 at 42.1 seconds, blew the crowd away when he broke his previously set record by a whopping 5 seconds. Other first place winners include the *Elaina Scott*, with Captain Scott Jones, and the *Elizabeth Joy*, with Captain Alan Parks.

On Saturday, the Smith Island Skiff Race was swept away by operator Sam Currie in his skiff Fiddler On The Bay. Second place was taken by Trey Shinault and third place was taken by Karl Nisson.
